FEES: NSCCT memberships are being provided on a pro-rated basis until the next renewal date for all members – April 1, 2012. The yearly rate cannot be used, but is provided to show what the pro-rated fees are based on. No need to send along this page with your membership application. Use it to determine the appropriate fee for your membership category based on the *month your membership will be processed* (the month after you send in your form).

All membership fees are calculated based on the first day of each month.

(For example: If your form and accompanying documents are received on October 21st, your membership will be processed for November 1st. Hence your cheque or money order should be chosen from the November 2011 row.)
